# FINANCE (SINGLE MAJOR) WITH SPECIALISATION IN BANKING

#### **ABOUT THE DEGREE**

In the Finance major, you will learn about investment evaluation strategies, how to fund investment and company activities and understand the importance of the capital structure of a company. The course also provides you with an understanding of the structure and operations of financial markets and financial instruments. You will also learn the skills to value financial securities, such as equities, fixed income instruments and derivative securities. The major also introduces students to the techniques of constructing portfolios and evaluation of portfolios.

The Banking specialisation will introduce you to banking practice and management, the different risk areas that banks are exposed to and the application of different financial models and methodology to manage these risks. You will also acquire the skills and knowledge needed to prepare and present holistic financial plan to meet clients' goals. You will also gain an understanding of international risks faced by banks operating in a global market place and the management of such risks.

The BCom Finance degree is accredited by the CFA Institute.
